# Urgent public warning! Pfizer-tied vax group targets infant and toddler parents

Again, our children are under attack. This time the 'experts' are re-targeting parents of children 6 months to 4 years of age.

#### Parents got wise to the CDC

In March, the CDC attempted to gin up demand for the mRNA shot with a MMRW <u>report</u> showing Omicron hospitalizations in this age group peaked at 14.5/100,000. They failed to mention the 2015-16 flu season averaged (not peaked) 76.9/100,000. In other words, on an average day during that influenza season, more than 5X as many children were hospitalized with the flu than with the highly infectious Omicron variant at its worst.

As more parents learn the truth about the mRNA data, many are taking a wait-and-see approach. In a recent <u>article</u>, I showed how the gene therapy rollout for infants and toddlers has been a disaster. According to a July 2022 Kaiser Family Foundation study, just 5% of eligible children were jabbed.

# A new group aims industry-funded propaganda at parents

Now the <u>COVID-19 Education and Equity Project</u> wants to persuade parents the experimental vaccines are safe and effective by propagandizing more pediatricians to push infant jabs. (BTW. The project is funded by Pfizer, Johnson and Johnson, and Novartis.)

The group recently held a <u>webinar</u> responding to parents' and peers' vaccine concerns.

But their professional responses are less than candid. Their website claims to stand for...

communicating transparent, scientifically accurate information about vaccines and vaccine technology...

They use bold but patently false statements to erase vaccine hesitation.

COVID-19 vaccination is the safest, most reliable way to get our lives and our economy back on track.

Much of their propaganda blurs the distinction between the experimental mRNA therapies and traditional vaccines.

Example:

For decades, vaccine development in the U.S. has followed a gold-standard review process that includes rigorous research, multi-stage clinical trials, robust regulatory review and approvals, and ongoing safety monitoring once an authorized vaccine becomes publicly available.

## The truth is...

- Pfizer's review process was bungled when they abruptly ended their vaccine trials months before the FDA's recommended period.
- The original trial resulted in more all cause mortality (ACM) deaths in the vaccine group than in the placebo arm.
- Pfizer and the FDA attempted to take 75 years to release the critical 90-day post marketing data. When it was finally released under a court order the data revealed that 1223 people died from the vaccine during the same 90 day period in which the CDC swore there were no vaccine related deaths.

• Brooke Jackson, a regional director for one of the groups conducting the Pfizer trials was fired when she <u>exposed</u> issues with data integrity and oversight.

## Definite harms of the mRNA preparation

Gene therapy proponents routinely tout the <u>benefits</u> of the mRNA jab without weighing them against its adverse effects.

- We know that in a Singapore study of 5 to 11 year olds, <u>22 vaccinated children</u> suffered "serious adverse events," and 3 were admitted to intensive care. In the unvaccnated group 1 was admitted to the ICU and obviously there were no vaccine-related adverse effects.
- A preprint study from <u>Thailand</u> shows a "disturbing" high relationship between myocarditis and the Pfizer jab in teens.
- A <u>study</u> of 600,000 children in Scotland and Brazil shows the jab's effectiveness after the second dose wanes in just 27 days.
- There is strong indication the jabs may be creating long term <u>damage</u> to children's natural immunity.

All to afflict children who are at less risk of hospitalization and death from Omicron than from a season of heavy flu; with a pseudo-vaccine that has never been properly tested.

We can't risk more parents being persuaded by pharma's latest propaganda campaign.
