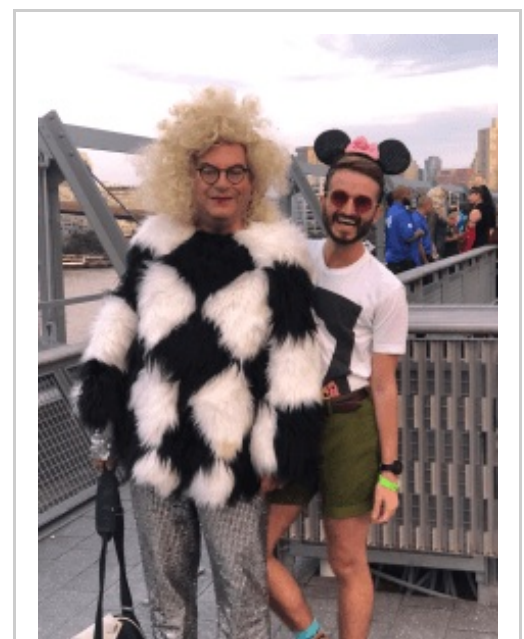
Not that the corporate owned media has any credibility, but you would think that they would know when enough is enough. Apparently not.
