

I recently read that the ACLU has filed and is filing frivolous lawsuits related to the behavior of sodomy involving people who are trying to force the States to sanction the behavior of sodomy as if it was a gender or ethnicity – that is something a person is born with. These lawsuits pretend that “same-sex” behavior should be treated as a normal behavior and sanctioned by the State. I believe it is important when defending the States against these lawsuits that you do not fall into the gender/ethnicity trap that sodomites use to justify their behavior. Since over the last 100 years or so the “Progressive Movement” in their zeal to control and regulate people's behavior, it is important that people be reminded that this behavior has historically been defined as “the engaging of sexual behavior by a person with a person of the same gender or sex as if one of the individuals is the opposite sex” - i.e. man on man or woman on woman sexual behavior where one of the individuals takes on the role of the opposite gender.

Real marriage, that is between a man and woman, is based upon the natural behavior of procreation and is sanctioned by society due to the nature of procreation. In order to insure children that are born have both parents available to raise them the State has an interest in insuring that the result of natural behavior of sexual reproduction are protected and raised. In order for a society to prosper children must be born and properly raised by their parents. And as children are members of society the State has an societal interest in insuring children are properly raised and not abused. Thus we have laws related to behaviors of all types – from theft, killing, sexual behavior, marriage and the raising of children.

The behavior of marriage is regulated by the States. The behavior of polygamy, where a man may have multiple wives, (or one woman with multiple husbands) has not been allowed in the United States since 1862. Children under the age of 16 are not allowed to marry in most States. In fact most States have laws against individuals under the age of 16 engaging in sexual activity. If the States and Federal Government can prohibit marriage based upon age as well as normal sexual behavior there is no grounds to force a State to sanction same-sex based “marriage”. In fact if a man or woman engage in normal sexual relations with a person under the age of consent it is treated as “statutory rape” even if the person under the age of consent was the instigator of the sexual contact. Thus a State has the authority to determine what type of behavior the State or society will tolerate or sanction.

In order to justify and force States and society to sanction the behavior of sodomy the practitioners of sodomy pretend they were born that way. In the 1970's people made excuses for the behavior – good, bad or indifferent – using the statement “The Devil made me do it.”. Now in order to justify their behavior people are claiming “I was born that way.”. We hear these excuses for various criminal behavior from theft, pedophilia and rape claiming they could not control their behavior. A person makes a choice to engage in the behavior sodomy just as a person make a choice to engage in natural sexual behavior. For a person to claim they were born a sodomite is the same thing as a man or woman to claim they were born a prostitute – a behavior. Or an adult to claim they were born a drug addict. Please note I am not referring to children born with a dependency due to the mother's addiction. For a person to be a drug addict or an alcoholic they have to make a conscience choice to consume the substance they are addicted to.

As with all behavior, which sodomites refuse to admit they are engaging in, will imprint itself on a person the longer they engage in the behavior. This is why ex-drug addicts and ex-convicts have a problem falling back into the behavior. This imprinting can also be seen in the children who have been abused – be it sexual, physical or psychologically. The children often go on to be offenders of the same type of behavior. The behavior has been imprinted on them and unless they are treated it is almost guaranteed they will engage in the behavior. This is one reason the Sodomite community is pushing so

hard to present their behavior as a normal and natural behavior. When a child goes through puberty they can be tricked into thinking they are a sodomite when their body responds to the pheromones and hormones that are naturally in their environment. The sodomite community goes so far as to claim normal dominance behavior in animals are examples of sodomy. This is called anthropomorphism and has been known to result in people's deaths – especially when dealing with predators. Then there is the need to consider the real consequences of the behavior to society.

The Sodomite community claims the behavior is normal and natural. All one has to do is to look at history and see the consequences of the behavior. From Rome to 1920/1940s Germany this behavior was responsible for numerous problems.

I use the terms “sodomy” and “sodomite” since they convey the nature of the behavior best. The word “homosexual” was coined in the 1890s to describe this behavior. And the term “lesbian” is a distortion of the history of the Isle of Lesbos in which women were powerful. They did not, to my knowledge, engage in sodomy but were consorts of powerful men and were powerful in their own right. And the “gay” means happy. It is not a description of behavior but a state of mind.

So in any defense against the lawsuits where the State and society are trying to be forced to accept and sanction this deviant, unnatural and unhealthy behavior it is important to point out that 1) it is a behavior a person makes a choice to engage in, 2) no State is obligated to accept or sanction every behavior a person may choose or want to engage in, and 3) the State already prohibits numerous behaviors a person may want to choose to engage in. Added to this the U.S. Constitution does not require a State to sanction the behavior of a person in another State just because the other State allows the behavior.
